Attendant registration includes registration as an Owner in accordance with the rules of GRV

You will receive "The Adviser" without paying a subscription fee, during your registration period as an attendant.

If your application is successful, you will receive a registration card that remains the property of GRV.

GRV has the right to cancel or suspend your registration at any time.

You must notify GRV of any change of address within 3 days.

**DECLARATION (MUST BE SIGNED IN ORDER TO GAIN REGISTRATION)**

I am aware that GRV is collecting this information for the purpose of administering and promoting greyhound racing. I understand that GRV only discloses this information to organisations, which help GRV to administer and promote greyhound racing and in order to comply with applicable laws and regulations. For example, GRV may specifically provide my personal information to my local council to allow them to administer the Domestic (Feral and Nuisance) Animals Act 1994, Centrelink to administer the Social Security (Administration) Act 1999 and to the media for the purpose of promoting or advertising greyhound racing.
