# **Purpose & Background**

#### **Purpose**

GRV has completed an extensive Review of Prizemoney and Breeding Incentives which examined the suitability of the current structure of prizemoney, starters' & travel fees and breeding incentives for greyhound racing in Victoria.

The Review has looked at options to improve returns to participants (owners, trainers, breeders), including changes aimed at improving the spread of returns across the various sectors of greyhound racing in Victoria.

This document sets out the details of a proposed package of changes.

**GRV is now seeking feedback from industry participants, clubs and stakeholders** on a proposed package of Prizemoney and incentives, which it is intended would be implemented in late 2017.

### **Background**

- In 2016/17 approx. \$36.4M was paid in Prizemoney in Victoria. A further \$6.1m was paid in travel and starters' fees to trainers for their participation in the racing program.
- The proposed prizemoney package has been developed following feedback from the industry at **Stakeholder Engagement Workshops** conducted throughout 2016/17.
- The proposed package represents an annual increase of approximately \$3.1M in returns to participants..
- The proposed restructure directs more money to the bottom grades of racing and to trainers preparing, caring for and producing greyhounds for racing.

# The key outcomes of the proposed package are aimed at improving the spread of returns to a broad base of participants...

# **Key Outcomes**

Stable Greyhound Racing Population	<ul> <li>ensuring a greater number of greyhounds can have a viable racing career and stay racing for longer.</li> </ul>

# Vic greyhound prizemoney is the highest in the nation, but average prizemoney per race hasn't increased for 3 years...

#### **Current Situation**

- \$42.5M in Prizemoney, Travel & Starters' Fees was paid in Victoria in the 2016/17 racing year.
- Total returns to participants have increased by around \$2.6M since 2013/14 despite an increasing program over that time.
- Although the total money paid has increased and the program has been expanded, average total money paid per race has declined from \$2,733 in 2013/14 to \$2,605 in 2016/17 because the additional meetings and races have been added at Level 3 at half stakes.
- Of the 1,658 trainers who had a runner in Vic during 2016/17, \$23M (54%) of total Prizemoney,
   Travel and Starters' Fees went to owners & trainers of greyhounds trained by the top 100 trainers (6% of all trainers).
- Greyhounds trained by the top 300 trainers earned \$31.6M (75%) of all money.
- This spread of money is disproportionate to the number of starters they produce (53%).

# Average prizemoney per race has declined in recent years, because additional meetings and races have been added at Tier 3.

# A package of Prizemoney changes is proposed to take effect from late 2017, providing an annual increase in returns to participants of \$3.1M.

### <u>Proposed Changes – Prizemoney & Starters Fees</u>

- Increase Level 3 (Tier 3, HLV, All Maiden, Rankings) minimum prizemoney to \$955 per race;
- Add 4th prizemoney for all races run at Level 2 & 3 meetings; and
- Flatten base minimum prizemoney to be the same for all races conducted at Level 2 & 3 meetings
- Travel & Starters Fees replaced by Trainers Starters' Fees paid to trainers for <u>all starters</u> competing at a meeting
  - All Level 2 & Level 3 Meetings \$80 per starter; and
  - Metro Level 1 Meetings \$120 per starter

#### **Proposed Vic Bred Series Finals Breeders' Payments**

In addition, the proposal includes Breeders' payments of \$2,300 per race for all VIC Bred Series Finals (\$0.28M pa).

# The Proposed changes will have the most impact at lower levels of racing.

### **Impact Summary – Prizemoney & Starters Fees**

This proposed structure will result in an **additional \$2.83M (+6.5%)** pa, in prizemoney and Starters' Fees when comparing the 2017/18 expected racing program of 14,293 races being run under the current structure with the proposed structure.

This additional money will be distributed by meeting type as follows:

- Level 1 (Metro) +\$0.30M (+2%)
- Level 2 (Provincial Full Stakes) +\$1.41M (+6%)
- Level 3 (Tier 3, Healesville, All Maiden, Rankings Meetings) +\$1.12M (+17%)

# **Proposed Changes – Flattening Minimum Prizemoney and adding 4th Prize**

### **Minimum Prizemoney for Level 2 & 3 Races**

- Prizemoney is currently allocated within a race meeting based on the types of races conducted from nominations received. Higher graded races are allocated proportionally higher levels of prizemoney.
- It is proposed that for Level 2 and Level 3 Meetings the minimum prizemoney should be the same for all races, after increasing Level 3 minimum prizemoney and adding 4th prizemoney at these meetings.
- The **15% payment for distance races is to be retained**, as will prizemoney top-ups for feature races.
- This results in minimum prizemoney per race of \$1,830 for Level 2 and \$955 for Level 3 races.
- The \$80 Starters' Fee (\$640 per race) will mean more total money will be paid out for these meetings.

# **Proposed Changes – Metro Level 1 Racing**

#### Minimum Prizemoney for Level 1 (Metro) Races

- The current prizemoney structure for Level 1 Metro meetings (Sandown–Thu & Meadows–Sat) is retained, apart from changes to Starters Fess, as these meetings need to continue to attract the best greyhounds and trainers.
- The higher Starters' Fees of \$120 per runner is designed to encourage participation at the top level.
- \$960 per race will be distributed in Trainers Starters' fees for 8 runners, compared to \$392 on average per race (\$49 per starter) now paid for Metro Races.
- This will mean **on average an additional \$208** per race will paid in returns to trainers at these meetings.
- For Metro Level 1 races, 1<sup>st</sup> to 3<sup>rd</sup> will receive slightly less prizemoney to pay for the Starters' Fees for all runners.


# **Participation by Trainers & Greyhounds**

- Over the past 12 months, **1,671 trainers participated** in the racing program in Victoria. Of those **1,291** (77%) trainers had at least one winner.
- There were **7,906 individual greyhounds** with at least one start and 4,659 (59%) had at least one win in that period.
- The largest proportion of trainers (93%) compete at some stage in Level 2 racing and 85% of trainers compete in Level 3 races.
- Similarly, 90% of the greyhounds racing competed at some stage during the year at Level 2 meetings, while 22% of greyhounds raced at Level 1 and 68% at Level 3.
- A number of trainers and greyhounds will have competed at all three levels during the year.

# Proposed Changes are targeted at the lowest grades of racing...

- Under the proposed model prizemoney and Starters' Fees are being increased at the lowest levels of races
   by \$2.93M in total, through a redistribution from higher class races.
- Prizemoney and Starters' Fees for Maiden races will increase by a total of \$1.35M (+35%);
- Grade 5,6,7 and Restricted Win races will increase by a total of \$1.58M (+7%)
- These races represent 80% of all races run in Victoria. Because all greyhounds start their careers in these races, all greyhounds (and therefore trainers) share in the benefits of this approach.
- Although prizemoney for higher level races has been reduced slightly, by the time a greyhound makes its way to the higher classes it will have earned more money under this system than the current model, providing improved returns for owners and trainers at the earlier stages of a greyhound's career.



# **Proposed Changes - Trainers Starters' Fees**

#### **Trainers Starters' Fees**

The key change in the proposed prizemoney model is the introduction of **Trainer Starters' Fees** to be paid to the trainer for each individual starter at a race meeting; **\$80 per starter** at Level 2 (Prov) & Level 3 (Tier 3 & Half Stake); and **\$120 per starter** at Level 1 (Metro Sandown-Thu & Meadows-Sat) meetings.

- This replaces the current Travel Fee (\$70 per trainer) and Starters' Fees (\$10 per runner) which has been in place for several years.
- The trainer is paid for greyhounds they produce for racing, which encourages participation at all levels and assists in maintaining the welfare of greyhounds and the pool of available greyhounds for racing.
- The higher Metro rate recognises the need to encourage participation at the highest level.
- Most trainers do not receive training fees from owners, either because they or their family members are the owner of the greyhound, or because they are training on a 50/50 spilt of prizemoney arrangement with the owner(s) in lieu of training fees.

#### **Proposed method for paying Starters' Fees to Trainers**

- The new Starters' Fees will be paid direct to the trainer at the race meeting on the day of the race, in the same way as Travel & Starters' Fees are paid now.
- These payments are not included in official prizemoney, and therefore not shared with the owner, but go to the trainer to cover the costs of travel and the care and up-keep of the greyhound(s).
- The proposal will mean Starters' Fees will increase to around \$9.67M (from \$6.2M), which means that trainers will receive the direct benefit of an additional \$3.47M pa in Starters' Fees.
- Prizemoney & Starters Fees will be advertised in the following way for a Level 2 race as an example:
   Of \$1,830; 1st \$1,320, 2nd \$320, 3rd \$120, 4th \$70 and \$80 Trainer's Starters Fee for all runners.

# **Proposed Changes - \$283K in Breeders' Payments for VIC Bred Series Finals**

### **Proposed Vic Bred Series Final Breeders Payment**

- Add \$283K in new annual breeders payments on VIC Bred Series Finals.
- In 2017/18 there will be 123 VIC Bred Series Finals programmed for various types of races across all Victorian tracks including maidens, restricted wins and distance series.
- Breeders Payments of up to \$2,300 per race for all finals will be paid at the same rate regardless of total prizemoney or where they are conducted (Provincial and Metro Finals).
- This program provides a clear and immediate reward for successful Breeders that should encourage reinvestment in responsible breeding and rearing.
- Breeders of all finalists will receive a payment from 1<sup>st</sup> to last.

# **Proposed - Other Breeding Controls & Incentives**

#### **Other Breeding Controls and Incentives Recommendations:**

#### 1. Establish Breeder Registration Categories based on historical performance

 Categorise breeders into A, B, C groupings which will determine future breeding rights (ie no. of litters able to be bred pa) based on a rolling 10 year points-based performance measure system.

#### 2. Revised Vic Bred eligibility conditions to remove Vic registered persons restriction

 Encourage broader investment in Victorian greyhound racing by removing the restrictions in eligibility criteria for Vic Bred races, which requires that only Vic Bred pups <u>owned by Vic registered</u> <u>persons</u> (i.e. Vic residents) are eligible. Effective from late 2017.

#### 3. Improved recognition of quality breeders

- a) Publication of successful Breeder tables publish on-line and in Greyhound Monthly tables of successful breeders and articles based on the performance of their pups, broodbitches, sires etc. over the previous 12 month period.
- **b)** Breeder Names in form-guides provide acknowledgement for the breeders in on-line and printed form-guides
- **c)** Annual Awards to recognise successful Breeders Breeders currently receive no recognition at Annual Awards functions. A series of awards will be established to acknowledge the best breeders in various categories across the year.
