Greyhound Racing Victoria (GRV) is the statutory authority responsible for regulating, conducting and promoting greyhound racing in Victoria, a sport that annually generates around \$400 million in economic activity and over \$2 billion in wagering and directly involves over 15,000 people.

The Racing Safety and Clubs Project Officer (RSCPO) is responsible for driving key projects within the Clubs and Safe Racing work groups at GRV. The role is required to support the management of the relationship between GRV and Greyhound Clubs Victoria (GCV) executive as well as running key projects as they relate to the Racing Safety Strategy.

The role is also required to develop strategies and frameworks that ensure the Victorian greyhound racing industry provides for a safe racing environment. The position is also responsible for the coordination and management of Safe Racing Strategy which seeks to improve the safety at all Victorian greyhound tracks and beyond.

The RSCPO is responsible for supporting and assisting Victorian greyhound racing's 13 registered clubs to improve operational and commercial effectiveness and strengthen their governance practices. This coordination will be primarily facilitated through Greyhound Clubs Victoria Executive Management.

The ability to manage competing requests and develop effective working relationships across all levels of GRV, and most importantly across the industry will be crucial to the success of the role.

With strong analytical skills and an ongoing focus on improving systems and processes, the RSCPO support the DRSCI working across all GRV departments, GRV Clubs and stakeholder groups including GOTBA, ensuring Victoria maintains its position as a world leader in the conduct, management and ongoing improvement of greyhound racing.
